SC SWCS CHAPTER TO HOST SYMPOSIUM TO ENCOURAGE ENVIRONMENTAL PLANNING IN URBAN DEVELOPMENT

December 11th symposium will highlight 'green development' success stories

The SC Chapter is planning a symposium which will educate developers, engineers, planners, natural resource professionals, and others about the integration of urban development with environmental planning.

Balancing Growth with Environmental Integrity in Urban Development will highlight the importance of environmental planning, particularly in Richland and Lexington Counties. Success stories from Lexington County's Stormwater Management Division, and from the Mungo Company, will illustrate how the pressures of urban development can be balanced to ensure protection of our state's natural resources.

SC SWCS Chapter President Amy O. Maxwell said, "This symposium was planned because of the rising demand for communities that offer more open space and preserve natural features, such as buffers. Homebuyers in South Carolina, and the nation as a whole, are starting to understand the importance and necessity of environmental protection, particularly in high-density urban areas. They are actively seeking housing developments that evaluate environmental impacts before and during construction. So, it's in the best interest of developers and planners to maintain open space, leave the natural vegetation and timber, and in turn, they may increase their profits over traditional developments."

SMART FARMING: THE BASICS OF PRECISION AGRICULTURE

January 15, 2008 11:30a.m.-5:00p.m., Myrtle Beach, SC, Kingston Plantation


This conference will concentrate on the Basics of Precision Agriculture, with an overview of the equipment needed for precision agriculture and how infrared yield maps can detail progress in precision agriculture. The conference will also focus on the details of precision irrigation, which uses a variable rate application system while using GIS technology.

A farmer-led panel will share personal experiences with precision irrigation and agriculture. In addition, attendees will also be treated to a view of agriculture in Afghanistan from Alex Johnson, retired NRCS employee, who lived and worked in Afghanistan for over a year.

Personal Perspective on the '07 SWCS International Conference

Held in Tampa, Florida July 21 - July 25 By Lori Bataller - SC Chapter Delegate

July 21, 2007—Leadership Workshop, Theo Daliaha gave a brief talk about the survey which was completed by the members online. The number one reason for others joining is **they were** asked by another member to join. Have you asked someone to join?

Tom Pick, a member of the Montana Chapter of SWCS, said in an effort to boost the number of attendees at symposiums, they focus on controversial topics. They also send a letter to all natural resources agencies asking for their employee training needs, so they can develop workshops which fill those needs. When hosting a workshop you should be very specific and define your target audience. The Chapter also adds a small technical section to the state chapter newsletter to give the members something besides just news. Also, try partnering with other conferences to get our name out. **The major selling point of any conference is the CEU credits.** There is a 16-page booklet available on the SWCS website that explains how to get the credits approved for any type of workshop. There is also a website that is easy to send out surveys called surveymonkey.com which charges \$25. Should we look at sending a survey to our members to find out their needs?

Pamela Reed Rhodes, President of the Mississippi Chapter reported that it is critical to have a good grassroots campaign when trying to diversify your membership. Some examples of good contacts were Rural Water Companies, USGS member, Urban Foresters and local Utility Companies.

In order for any group to be seen as credible with a news outlet we as individuals need to develop a relationship with the news media. Don't overload them with too many news releases. **Make sure your information is correct and current.**

TOP 3 ITEMS TAKEN FROM THE LEADERSHIP WORKSHOP

- 1. Keep connected between meetings, send the minutes out and then refresh everyone at least a week before the meeting so they have time to ensure their particular task are complete.
- **2.** We must have good partnerships in order to flourish and grow. Don't just look for people and topics you are familiar with__ step out and find new ways to grow.
- 3. And most importantly (spoken by Norm Berg, Washington DC Representative, SWCS, about his retirement) "the problem with doing nothing is you don't know when you're finished." We can all use this as a call to duty as we need to be involved so we know when we have completed our mission.

July 22, 2007—House of Delegates Meeting, the major focus of the meeting was on the Missouri Chapters resolution to create a new membership option that would allow members to take the Journal or not. After a slide show detailing the cost of the journal and the reduction of only \$10 a year in dues it was decided unanimously to keep the membership cost the same. The Journal is a large money maker for the Society because of the ads, and the more subscribers we have, the larger the number of ads placed.

There is a new Corporate Membership option available to businesses. Contact Sue Ann Lynes and she will set everything up for a sponsorship. There are three categories--gold, silver and bronze. For each corporate member that joins SWCS, the local chapter will receive some money ranging from \$300 to \$100.

Each of the local staff from Ankeny, Iowa gave a presentation of their roles in the organization. If we have any questions we need to contact them as they are there to help us with professional development, membership, and communications.

July 23, 2007—2007 Farm Bill Overview, the invited guest speakers were required to be on Capital Hill as the farm bill was scheduled to be brought up for a vote. In their place Craig Cox, SWCS Executive Director, gave an in-depth overview of the proposed farm bill. It was a very interesting session and the bill looks as if the money for conservation programs will remain about the same with a few changes in the acronyms.

July 24, 2007—The Role of Conservation in a Bio-Fuels Economy? This special plenary session consisted of a round table panel of researchers, policy analyst, corporation heads and environmentalist. This was a very exciting discussion about long-term effects of the bio-fuels. The use of corn was discussed as not being sustainable due to the removal of the organic matter and the loss of carbon sequestration. Switchgrass as an alternative is not really viable at this time because of the initial planting and the length until which a good stand is achieved. Also, we need to find a way to increase yields on existing cropland without clearing new land to put into production. They also discussed water resources or the lack there of in areas where new production plants would be installed.

South Carolina SWCS was recognized!! The South Carolina Chapter received two awards which I was proud to accept on behalf of the chapter. The awards were Chapter Achievement Award for the LID conferences and for Outstanding Chapter Award for overall activities of the chapter.

The conference was great to attend. I was very fortunate to attend two years in a row and I feel like everyone in the Society should take the opportunity to attend an annual conference if given the opportunity.
